**RESOLUTION ACCEPTING THE LOW BID OF DOGGETT MACHINERY SERVICES IN THE AMOUNT OF \$112,000.00 FOR A NEW CRAWLER DOZER AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER ANY AND ALL RELEVANT DOCUMENTS.**

**WHEREAS**, a bid document was issued for public bids for a new crawler dozer; and

**WHEREAS**, three (3) bids were received as follows: and

Doggett Machinery Services	\$112,000.00
Lee Tractor Co, Inc.	\$112,455.00
H&E Equipment Services, Inc.	\$124,142.00

**WHEREAS**, the lowest bid was received by Doggett Machinery Services in the amount of \$112,000.00; and

**WHEREAS**, the funding will come from RSTD-A; and

**WHEREAS**, this resolution was sponsored for Administration by Mr. John Arnold, Councilman, District 5; and

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council accepts the low bid of Doggett Machinery Services in the amount of \$112,000.00 for a new crawler dozer and authorizes the Parish President to sign, execute and administer any and all relevant documents.

**THEREFORE, BE IT RESOLVED**, that the Lafourche Parish Council convened in regular session on September 23, 2014, and does hereby accept the low bid of Doggett Machinery Services in the amount of \$112,000.00 for a new crawler dozer and authorizes the Parish President to sign, execute and administer any and all relevant documents.
