**RESOLUTION NO. 14-269**

**RESOLUTION APPROVING THE LOW QUOTE OF LOW LAND CONSTRUCTION CO., INC. IN THE AMOUNT OF \$29,900.00 FOR THE REPLACEMENT OF THE 30-INCH DIAMETER DISCHARGE PIPE AT THE ALIDORE PUMP STATION AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER AN AGREEMENT AND ANY AND ALL RELEVANT DOCUMENTS.**

**WHEREAS**, the 30-inch discharge pipe is deteriorated at the Alidore Pump Station; and

**WHEREAS**, three (3) quotes were requested and received as follows to replace the pipe:

**WHEREAS**, Low Land Construction Co., Inc. has the lowest quote in the amount of \$29,900.00; and

**WHEREAS**, funding will come from the 2014 Drainage Fund for repairs; and

**WHEREAS**, this resolution was sponsored for Administration by Mr. Lindel Toups, Councilman, District 6; and

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council approve the low quote of Low Land Construction Co., Inc. in the amount of \$29,900.00 for the replacement of the 30-inch diameter discharge pipe at the Alidore Pump Station and authorizes the Parish President to sign, execute, and administer an agreement and any and all relevant documents.
