The following ordinance, having been previously introduced and published, was offered for final adoption by Mr. Aaron Caillouet, seconded by Mr. Jerry Jones.

ORDINANCE NO. 5515

ORDINANCE AMENDING ORDINANCE NO. 4143 AMENDING AND RE-ENACTING CHAPTER 22, ARTICLE II SECTION 22-19 OF THE CODE OF ORDINANCES OF THE LAFOURCHE PARISH COUNCIL AS IT PERTAINS TO CREATION, LIMITS AND AUTHORITY OF PARISH PLANNING COMMISSION; DOMICILE; POWERS AND DUTIES AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, The Lafourche Parish Council hereby amends Ordinance No. 4143 and amends and re-enacts Chapter 22, Article II, Section 22-19 to read as follows:

Sec. 22-19. Creation, limits, and authority of parish planning commission; domicile; powers and duties.

- (c) The power of the parish planning commission and the control and management of the affairs of the commission shall be vested in a board of commissioners composed of five qualified electors residing within the unincorporated areas of the parish. The individual commissioners of the parish planning commission shall be appointed by the parish council with ~~three commissioners each being appointed~~ **one** from the north, **one from the** central, **and one from the** south, **and the remaining members from any** parish regions, as established pursuant to the Charter. The terms of office of the commissioners shall be at the pleasure of the council.

WHEREAS, On June 26, 2014, the Lafourche Parish Planning Commission recommended approval of these changes to the Parish Council; and

WHEREAS, all other articles, divisions, and sections in this chapter shall remain the same; and

WHEREAS, this ordinance was sponsored for Administration by Mr. Aaron Caillouet, Council District 3; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council approve amending Ordinance No. 4143 and amending and re-enacting Chapter 22, Article II section 22-19 of the Code of Ordinances of the Lafourche Parish Council as it pertains to creation, limits, and authority of parish planning commission; domicile; powers and duties and authorizing the Parish President to sign, execute and administer any and all relevant documents.

THEREFORE BE IT ORDAINED, that the Lafourche Parish Council convened in Regular Session on August 12, 2014, and hereby approve amending Ordinance No. 4143 and amending and re-enacting Chapter 22, Article II section 22-19 of the Code of Ordinances of the Lafourche Parish Council as it pertains to creation, limits, and authority of parish planning commission; domicile; powers and duties and authorizes the Parish President to sign, execute and administer any and all documents; and

BE IT FURTHER ORDAINED, that a certified copy of this Ordinance shall be forwarded to MUNICODE, the Lafourche Parish Government Department of Planning & Permitting and the Office of the Parish Administrator; and

BE IT FURTHER ORDAINED, that;

SECTION 1. If any provision or item of this Ordinance or the application thereof is held invalid, such invalidity shall not effect other provisions, items or application of this Ordinance which can be given affect without the invalid provisions, items or application, and to this end the provisions of this Ordinance are declared severable.

SECTION 2. All Ordinances by the Lafourche Parish Council conflicting with or inconsistent with the provisions of these regulations are hereby repealed.

SECTION 3. This Ordinance shall be published in the Official Journal of the Lafourche Parish Council in the manner provided by law.

SECTION 4. This Ordinance, having been submitted in writing, having been read and adopted by sections at a public meeting of said Council, was then submitted to an official vote as a whole, the vote thereon being as follows:
