**RESOLUTION NO. 14-169**

**RESOLUTION REAPPOINTING ONE (1) COMMISSIONER TO THE BAYOU BLUE FIRE PROTECTION DISTRICT OF TERREBONNE AND LAFOURCHE PARISH BOARD.**

**WHEREAS**, the Bayou Blue Fire Protection District of Terrebonne and Lafourche Parish Board currently has one (1) vacancy which occurred from an expired term; and

**WHEREAS**, Mr. Peter Parks' term expired on May 7, 2014; and

**WHEREAS**, this position was advertised and one (1) application was received; and

**WHEREAS**, Mr. Peter Parks submitted his application to fill one (1) position; and

**WHEREAS**, this resolution was sponsored for administration by Mr. John Arnold, District 5; and

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council take action on this application.

**THEREFORE, BE IT RESOLVED**, that the Lafourche Parish Council convened in regular session on June 24, 2014, and does hereby reappoint Mr. Peter Parks on the Bayou Blue Fire Protection District of Terrebonne and Lafourche Parish Board to serve a two (2) year term beginning June 24, 2014, and ending June 23, 2016.
