RESOLUTION NO. 14-219

RESOLUTION APPROVING A CONTRACT BETWEEN LAFOURCHE PARISH GOVERNMENT AND THE SCHOOL FOOD AND NUTRITION SERVICES OF NEW ORLEANS, INC. TO PROVIDE FOOD SERVICES TO THE LAFOURCHE PARISH HEAD START SITES AT SOUTH LAFOURCHE 1, 2 & 3 AND MGC 1, 2 & 3 AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER SAID CONTRACT AND ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, the School Food and Nutrition Services of New Orleans, Inc. has offered the Lafourche Parish Head Start a contract to provide food services; and

WHEREAS, the food services will consist of three (3) meals per day; breakfast at \$2.10, lunch at \$3.80, and a snack at \$1.10, for a total of \$7.00 per day; and

WHEREAS, this contract is for the term of nine (9) months commencing from August 28, 2014 and ending on the last day of school in May, 2015; and

WHEREAS, this resolution was sponsored for Administration by Mr. Jerry LaFont, Councilman, District 8; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council approves said contract between Lafourche Parish Government and the School Food and Nutrition Services of New Orleans to provide food services to the Lafourche Parish Head Start sites at South Lafourche 1, 2 & 3 and MGC 1, 2 & 3 and authorizes the Parish President to sign, execute and administer said contract and any and all relevant documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on August 12, 2014, and does hereby approve said contract between Lafourche Parish Government and the School Food and Nutrition Services of New Orleans to provide food services to the Lafourche Parish Head Start sites at South Lafourche 1, 2 & 3 and MGC 1, 2 & 3 and authorizes the Parish President to sign, execute and administer said contract and any and all relevant documents.

BE IT FURTHER RESOLVED, that a certified copy of this resolution shall be forwarded to School Food and Nutrition Services of New Orleans, Inc., 1000 Howard Ave., Suite 300 New Orleans, LA 70113-1925; Lafourche Parish Government Department of Head Start; Department of Finance; and the Office of the Parish Administrator.
