

The following ordinance was introduced by Mr. Lindel Toups in regular session convened on September 23, 2014.

PROPOSED ORDINANCE

The following ordinance, having been previously introduced and published, was offered for final adoption by Mr. Phillip Gouaux, seconded by Mr. Lindel Toups.

ORDINANCE NO. 5538

ORDINANCE PROVIDING FOR A 2014 SUPPLEMENTAL APPROPRIATION (14-027) WITHIN THE 2014 OPERATIONS AND MAINTENANCE AND CAPITAL BUDGET TO INCREASE THE BUDGET FOR REPAIRS TO THE RITA STREET BRIDGE IN LOCKPORT, LOUISIANA UNDER THE LOUISIANA LOCAL GOVERNMENT ASSISTANCE PROGRAM AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER SAID TRANSACTIONS AS PROVIDED FOR BY ARTICLE VI OF THE LAFOURCHE PARISH HOME RULE CHARTER.

WHEREAS, this program assist local governments with funding for needed infrastructure and long term capital improvements; and

WHEREAS, the Louisiana Office of Community Development has approved the Louisiana Local Government Assistance Grant Application submitted by Lafourche Parish Government and awarded a contract of up to \$39,800.00 to make repairs to the Rita Street Bridge in Lockport, Louisiana; and

WHEREAS, this ordinance was sponsored for Administration by Mr. Lindel Toups, Councilman, District 6; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the council approve a 2014 Supplemental Appropriation (14-027) within the 2014 Operations and Maintenance and Capital Budget to increase the budget for repairs to the Rita Street Bridge in Lockport, Louisiana under the Louisiana Local Government Assistance Program and authorizes the Parish President to sign, execute, and administer said transactions as provided for by Article VI of the Lafourche Parish Home Rule Charter.

THEREFORE BE IT ORDAINED, by the Lafourche Parish Council, convened in Regular Session on October 14, 2014, and hereby approves a 2014 Supplemental Appropriation (14-027) within the 2014 Operations and Maintenance and Capital Budget to increase the budget for repairs to the Rita Street Bridge in Lockport, Louisiana under the Louisiana Local Government Assistance Program and authorizes the Parish President to sign, execute, and administer said transactions as provided for by Article VI of the Lafourche Parish Home Rule Charter; and

BE IF FURTHER ORDAINED, that:

SECTION 1. A Supplemental Appropriation of the 2014 Operations and Maintenance Budget is hereby approved as follows:

FUND 103 ROAD AND BRIDGES FUND

To cover repairs of Rita Bridge (BR009):

1. An increase in INTERGOVERNMENTAL REVENUE in the amount of \$39,800
2. An increase in MISCELLANEOUS in the amount of \$39,800

SECTION 2. A Supplemental Appropriation of the 2014 Capital Budget is hereby approved as follows:

FUND 299 CAPITAL PROJECTS

To cover repairs of Rita Bridge (BR009):

1. An increase in OTHER REVENUES in the amount of \$39,800
2. An increase in CAPITAL OUTLAY in the amount of \$39,800

SECTION 3. If any provision or item of this ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items or application of this ordinance which can be given affect without the invalid provisions, items or application, and to this end the provisions of this ordinance are declared severable.

SECTION 4. All Ordinances by the Lafourche Parish Council conflicting with or inconsistent with the provisions of these regulations are hereby repealed.

SECTION 5. This Ordinance shall be published in the Official Journal of the Lafourche Parish Council in the manner provided by law.

SECTION 6. A certified copy of this ordinance shall be forwarded to Lafourche Parish Government's Department of Finance, Department of Public Works, Department of Grants and Economic Development and the Office of the Parish Administrator.

SECTION 7. This Ordinance, having been submitted in writing, having been read and adopted by sections at a public meeting of said Council, was then submitted to an official vote as a whole, the vote thereon being as follows:
