**RESOLUTION NO. 14-277**

**RESOLUTION ACKNOWLEDGING AND ACCEPTING A GRANT FROM ENTERGY CORPORATION IN THE AMOUNT OF ONE THOUSAND DOLLARS (\$1,000.00) TO ASSIST IN THE OPERATION OF THE LAFOURCHE PARISH COUNCIL OFFICE OF COMMUNITY ACTION AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER SAID DOCUMENT AND ANY AND ALL RELEVANT DOCUMENTS.**

**WHEREAS**, the Lafourche Parish Council Office of Community Action works to attain a measurable and positive impact on the causes of poverty in Lafourche Parish; and

**WHEREAS**, the Lafourche Parish Council Office of Community Action is committed to assisting low income individuals and families; and

**WHEREAS**, Entergy Corporation offers Micro Grants of \$1,000.00 or less; and

**WHEREAS**, Micro Grants allow Entergy to address the needs of organizations year-round and throughout their entire area of operations; and

**WHEREAS**, Lafourche Parish Council Office of Community Action applied online for a Micro Grant in the amount of One Thousand Dollars (\$1,000.00) and received said grant; and

**WHEREAS**, this resolution was sponsored for Administration by Mr. Daniel Lorraine, Councilman, District 9; and

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council acknowledge and accept a grant from Entergy Corporation in the amount of One Thousand Dollars (\$1,000.00) to assist in the operation of the Lafourche Parish Council Office of Community Action and authorizes the Parish President to sign, execute, and administer said document and any and all relevant documents.

**THEREFORE BE IT RESOLVED**, that the Lafourche Parish Council, convened in regular session on October 14, 2014, and does hereby acknowledge and accept a grant from Entergy Corporation in the amount of One Thousand Dollars (\$1,000.00) to assist in the operation of the Lafourche Parish Council Office of Community Action and authorizes the Parish President to sign, execute, and administer said document and any and all relevant documents.
