RESOLUTION NO. 14-281

RESOLUTION RATIFYING THE RE-APPOINTMENT OF MR. GLENN CHANCE, JR. AS THE NICHOLLS STATE UNIVERSITY REPRESENTATIVE ON THE LAFOURCHE PARISH CIVIL SERVICE BOARD.

WHEREAS, according to Section 4 of Article IV of the Lafourche Parish Home Rule Charter, one (1) member shall be nominated by the Board of Directors of the Alumni Association of Nicholls State University, the selected nominee is then submitted to the President who shall thereafter submit the name to the Council for approval or rejection of the appointment; and

WHEREAS, appointments to said Board shall be for four (4) years; and

WHEREAS, in an e-mail dated September 4, 2014, the Nicholls State University Alumni Federation has nominated Mr. Glenn Chance, Jr. to be re-appointed to the Civil Service Board; and

WHEREAS, this resolution was sponsored for the Administration by Mr. Aaron Caillouet, Councilman, District 3; and

THEREFORE, BE IT RESOLVED, by the Lafourche Parish Council convened in regular session on October 14, 2014, and does hereby ratify the re-appointment of Mr. Glenn Chance, Jr. as the Nicholls State University representative on the Lafourche Parish Civil Service Board for a four-year term expiring on December 14, 2018; and

BE IT FURTHER RESOLVED, that a certified copy of this resolution be forwarded to the Lafourche Parish Civil Service Department and the Lafourche Parish Administration.
