RESOLUTION NO. 14-286

RESOLUTION APPROVING THE PURCHASE OF ONE (1) DODGE CARAVAN SE FOR LAFOURCHE PARISH HEAD START IN THE AMOUNT OF \$20,607.00 AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, Lafourche Parish Head Start is in need of a van to transport staff and parents and to replace an older van; and

WHEREAS, the van will be purchased through state purchasing from Southland Dodge, Commodity No. 070-93-018483, Contract No. 409703, for a cost of \$20,607.00; and

WHEREAS, all funds have been allocated within the Head Start budget; and

WHEREAS, this resolution was sponsored for Administration by Mr. Phillip Gouaux, Councilman, District7; and

WHEREAS, it is recommended by the Administration of Lafourche Parish Government that the Council approve the purchase of one (1) Dodge Caravan SE for Lafourche Parish Head Start in the amount of \$20,607.00 and authorizes the Parish President to sign, execute and administer any and all relevant documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on October 14, 2014 and does hereby approve the purchase of one (1) Dodge Caravan SE for Lafourche Parish Head Start in the amount of \$20,607.00 and authorizes the Parish President to sign, execute and administer any and all relevant documents.

BE IT FURTHER RESOLVED, that a certified copy of this resolution shall be forwarded to Lafourche Parish Head Start; the Department of finance; Office of Risk Management; and the Office of the Parish Administrator.
