RESOLUTION NO. 14-288

RESOLUTION ACCEPTING THE LOW BID OF BEVERLY CONSTRUCTION CO., LLC IN THE AMOUNT OF \$853,582.50, FOR THE LOCKPORT COMPANY CANAL SOUTH BANK LEVEE LIFT AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER AN AGREEMENT AND ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, four (4) bids were received on September 3, 2014 as follows:

WHEREAS, Beverly Construction Co., LLC is the lowest responsive bidder in the amount of \$853,582.50 and said bid is deemed to be in order; and

WHEREAS, it is the recommendation of T. Baker Smith, LLC and this Administration that the low bid of Beverly Construction Co., LLC, be accepted; and

WHEREAS, Lafourche Parish has applied for and received funding in the amount of \$1,256,455.00 for the Lockport Company Canal South Bank Levee Lift Project, funded under the CDBG Hurricanes Gustav and Ike Parish-Implemented Recovery Program; and

WHEREAS, this resolution was sponsored for Administration by Mr. Phillip Gouaux, Councilman, District 7; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council does hereby accept the low bid of Beverly Construction Co., LLC in the amount of \$853,582.50, for the Lockport Company Canal South Bank Levee Lift and authorizing the Parish President to sign, execute, and administer an agreement and any and all relevant documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council, convened in regular session on October 14, 2014, and does hereby accept the low bid of Beverly Construction Co., LLC, in the amount of \$853,582.50, for the Lockport Company Canal South Bank Levee Lift and authorizing the Parish President to sign, execute, and administer an agreement and any and all relevant documents.
