

On motion by Joe Fertitta, seconded by Aaron Caillouet, the following resolution was introduced and adopted;

**RESOLUTION NO. 14-292**

**RESOLUTION APPROVING CHANGE ORDER NO. 1 FOR THE PROJECT ENTITLED PUBLIC BOAT LAUNCH, LEEVILLE, LAFOURCHE PARISH, LA TO INCREASE THE CONTRACT PRICE BY \$8,700.00 AND INCREASING THE CONTRACT TIME BY 7 CALENDAR DAYS AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER SAID CHANGE ORDER AND ANY AND ALL RELEVANT DOCUMENTS.**

**WHEREAS**, this Change Order is being presented to increase the contract price by \$8,700.00 due to the removal and replacement of an existing storm drain pipe, new catch basin and new 18” storm drain pipe; and

**WHEREAS**, the contract price will be increased by \$8,700.00 for a new contract price totaling \$1,036,744.94; and

**WHEREAS**, contract time will be increased by 7 calendar days; and

**WHEREAS**, it is the recommendation of Picciola and Associates, Inc. and this Administration that said Change Order be accepted; and

**WHEREAS**, this resolution was sponsored for Administration by Mr. Daniel Lorraine, Councilman, District 9; and

**WHEREAS**, it is the recommended by the Administration of the Lafourche Parish Government that the Council approves Change Order No. 1 for the project entitled Public Boat Launch, Leeville, Lafourche Parish, LA to increase the contract price by \$8,700.00 and increase the contract time by 7 calendar days and authorizes the Parish President to sign, execute and administer said change order and any and all relevant documents.

**THEREFORE, BE IT RESOLVED**, that the Lafourche Parish Council convened in regular session on October 14, 2014, and does hereby approve Change Order No. 1 to the project entitled Public Boat Launch, Leeville, Lafourche Parish, LA to increase the contract price by \$8,700.00 and increase the contract time by 7 calendar days and authorizes the Parish President to sign, execute and administer any and all relevant documents.
