RESOLUTION NO. 14-293

RESOLUTION REAPPOINTING ONE (1) COMMISSIONER TO REPRESENT NICHOLLS STATE UNIVERSITY ON THE LAFOURCHE PARISH CHILDREN AND YOUTH PLANNING BOARD.

WHEREAS, Ms. Kimberly Reynolds, serves on the Lafourche Parish Children and Youth Planning Board and represents Nicholls State University on the Board; and

WHEREAS, according to the Lafourche Parish Government's records, Ms. Reynolds term expired on July 25, 2013; and

WHEREAS, in a letter from Nicholls State University, Dr. Stephen Hulbert recommends Ms. Kimberly Reynolds be reappointed to the Lafourche Parish Children and Youth Planning Board; and

WHEREAS, this resolution was sponsored for administration by Mr. Joe Fertitta, District No. 4; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council take action on this recommendation.
