RESOLUTION ACCEPTING THE LOW BID OF INFINITY PUMP & SUPPLY, LLC IN THE AMOUNT OF \$79,000.00 FOR THE BAYOU ONION EAST PUMP AND ASSOCIATED EQUIPMENT AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, a bid document was issued for public bids for a 24-inch hydraulic pump and associated equipment; and

WHEREAS, three bids were received as follows:

Infinity Pump & Supply, LLC	\$79,000.00
Associated Pump & Supply, Co.	\$87,700.00
M&L Engine, LLC	\$92,157.00

WHEREAS, Infinity Pump & Supply submitted the lowest responsive bid in the amount of \$79,000.00; and

WHEREAS, the funding will come from RSTD-A; and

WHEREAS, this resolution was sponsored for Administration by Mr. Michael Delatte, Councilman, District 2; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council accepts the low bid of Infinity Pump & Supply, LLC in the amount of \$79,000.00 for the Bayou Onion East Pump and associated equipment and authorizes the Parish President to sign, execute and administer any and all relevant documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on October 28, 2014, and does hereby accept the low bid of Infinity Pump & Supply, LLC in the amount of \$79,000.00 for the Bayou Onion East Pump and associated equipment and authorizes the Parish President to sign, execute and administer any and all relevant documents.
