RESOLUTION NO. 14-304

A RESOLUTION APPROVING THE PURCHASE AND INSTALLATION OF PLAYGROUND EQUIPMENT THROUGH NJPA CONTRACT PRICES (MEMBER #81,379) FROM MIRACLE RECREATION EQUIPMENT COMPANY IN THE AMOUNT OF \$24,985.00 FOR MARYDALE HEAD START AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER SAID AGREEMENT AND ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, Lafourche Parish Head Start is in need of playground equipment; and

WHEREAS, the playground equipment will be purchased and installed through National Joint Powers Alliance (NJPA) contract prices (member #81,379) from Miracle Recreation Equipment Company for a cost of \$24,985.00; and

WHEREAS, all funds have been allocated within the Head Start Budget; and

WHEREAS, this resolution was sponsored for Administration by Mr. Jerry LaFont, Councilman, District 8; and

WHEREAS, it is recommended by the Administration of Lafourche Parish Government that the Council approve the purchase and installation of playground equipment through NJPA Contract Prices (Member #81,379) from Miracle Recreation Equipment Company in the amount of \$24,985.00 for Marydale Head Start and authorizes the Parish President to sign, execute and administer said agreement and any and all relevant documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on October 28, 2014, and does hereby approve the purchase and installation of playground equipment through NJPA Contract Prices (Member #81,379) from Miracle Recreation Equipment Company in the amount of \$24,985.00 for Marydale Head Start and authorizes the Parish President to sign, execute and administer said agreement and any and all relevant documents.
