RESOLUTION NO. 14-316

RESOLUTION APPROVING THE HIRING OF ARGOTE, DERBES, GRAHAM, SHUFFIELD & TATJE OF NEW ORLEANS, INC., DBA VALBRIDGE PROPERTY ADVISORS FOR THE PURPOSE OF APPRAISING UP TO FOURTEEN (14) PARCELS FOR SERVITUDE AGREEMENTS FOR THE GUSTAV/IKE CDBG DISASTER RECOVERY PROGRAM/WESTSIDE DRAINAGE IMPROVEMENTS PROJECT AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, an appraisal is necessary to determine the “Fair Market Value” of up to fourteen (14) parcels for servitude agreements for the Gustav/Ike CDBG Disaster Recovery Program/Westside Drainage Improvements Project; and

WHEREAS, Argote, Derbes, Graham, Shuffield & Tatje of New Orleans, Inc., dba Valbridge Property Advisors has agreed to appraise up to fourteen (14) parcels for servitude agreements for the Gustav/Ike CDBG Disaster Recovery Program/Westside Drainage Improvements Project for a fee not to exceed \$17,500.00; and

WHEREAS, this resolution was sponsored for Administration by Mr. Aaron Caillouet, Councilman, District 3; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council approve the hiring of Argote, Derbes, Graham, Shuffield & Tatje of New Orleans, Inc., dba Valbridge Property Advisors for the purpose of appraising up to fourteen (14) parcels for servitude agreements for the Gustav/Ike CDBG Disaster Recovery Program/Westside Drainage Improvements Project and authorizes the Parish President to sign, execute, and administer any and all relevant documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on October 28, 2014, and does hereby approve the hiring of Argote, Derbes, Graham, Shuffield & Tatje of New Orleans, Inc., dba Valbridge Property Advisors for the purpose of appraising up to fourteen (14) parcels for servitude agreements for the Gustav/Ike CDBG Disaster Recovery Program/Westside Drainage Improvements Project, and authorizes the Parish President to sign, execute, and administer any and all relevant documents.
