On motion by Lindel Toups, seconded by Jerry Jones, the following resolution was introduced and adopted:

**RESOLUTION NO. 14-318**

**RESOLUTION APPROVING TO RENEW THE CONTRACTS BETWEEN LAFOURCHE PARISH GOVERNMENT AND GALLAGHER BENEFITS SERVICES AND JAMES STENTZ & ASSOCIATES FOR EMPLOYEE HEALTH COVERAGE WITH BLUE CROSS BLUE SHIELD OF LOUISIANA EFFECTIVE JANUARY 1, 2015 AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER SAID CONTRACTS AND ANY AND ALL RELEVANT DOCUMENTS.**

**WHEREAS**, health coverage will continue to be provided by Blue Cross Blue Shield with no changes in the group health plan; and

**WHEREAS**, there will not be any premium increases for the 2015 coverage year neither for employer nor employee; and

**WHEREAS**, this resolution was sponsored for Administration by Mr. Lindel Toups, Councilman, District 6; and

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council approve renewing the contracts between Lafourche Parish Government and Gallagher Benefits Services and James Stentz & Associates for Employee Health Coverage with Blue Cross Blue Shield of Louisiana effective January 1, 2015 and authorizing the Parish President to sign, execute and administer said contracts and any and all relevant documents.

**THEREFORE BE IT RESOLVED**, that the Lafourche Parish Council convened in regular session on November 11, 2014 and does hereby renew the contracts between Lafourche Parish Government and Gallagher Benefits Services and James Stentz & Associates for Employee Health Coverage with Blue Cross Blue Shield of Louisiana effective January 1, 2015 and authorizing the Parish President to sign, execute and administer said contracts and any and all relevant documents.

**BE IT FURTHER RESOLVED**, that a certified copy of this Resolution shall be forwarded to James Stentz & Associates (Mr. James Stentz), Gallagher Benefits Services (Mr. Byron Landry), Lafourche Parish Government Human Resources Department, Department of Finance, and the Office of the Parish Administrator.
