RESOLUTION APPROVING THE LOW BID OF SEALEVEL CONSTRUCTION, INC., FOR THE INDUSTRIAL PARK ROAD BULKHEAD PROJECT IN THE AMOUNT OF \$1,235,551.00 AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, Duplantis Design Group designed the replacement of a section of the Industrial Park Road bulkhead and then issued the bid documents for public bids; and
