RESOLUTION NO. 14-320

RESOLUTION APPROVING A CONTRACT BETWEEN LAFOURCHE PARISH GOVERNMENT AND J. WAYNE PLAISANCE, INC. FOR THE PROJECT ENTITLED DRAINAGE IMPROVEMENTS NEAR WEST 175TH STREET AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER SAID AGREEMENT AND ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, the services of an engineering firm are needed to assist with the project of drainage improvements near West 175th Street in Lafourche Parish to provide adequate drainage to residents; and

WHEREAS, this resolution was sponsored for Administration by Mr. Daniel Lorraine, Councilman, District 9; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council approves the contract between Lafourche Parish Government and J. Wayne Plaisance, Inc. for the project entitled Drainage Improvements near West 175th Street and authorizes the Parish President to sign, execute and administer said agreement and any and all relevant documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on November 11, 2014, and does hereby approve the contract between Lafourche Parish Government and J. Wayne Plaisance, Inc. for the project entitled Drainage Improvements near West 175th Street and authorizes the Parish President to sign, execute and administer said agreement and any and all relevant documents.
