RESOLUTION APPOINTING ONE (1) COMMISSIONER TO THE COASTAL ZONE MANAGEMENT ADVISORY COMMITTEE.

WHEREAS, Coastal Zone Management Advisory Committee currently has one (1) vacancy which occurred from a resignation; and

WHEREAS, Mr. Nicholas Cheramie's resignation was received on May 1, 2014; and

WHEREAS, in a letter from the Lafourche-Terrebonne Soil and Water Conservation District, it was recommended that Jerome Cantrelle be appointed to the Coastal Zone Management Board; and

WHEREAS, this resolution was sponsored for administration by Mr. Phillip Gouaux, District 7; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council take action on this recommendation.
