

On motion by Mr. Joe Fertitta, seconded by Mr. Aaron Caillouet, the following resolution was introduced and adopted:

RESOLUTION NO. 14-327

RESOLUTION APPROVING CHANGE ORDER NO. 2 FOR THE COUNTRY CLUB BOULEVARD TO EDGEWOOD DRIVE CULVERT PROJECT INCREASING THE CONTRACT PRICE BY \$7,662.10 AND INCREASING THE CONTRACT TIME BY FIVE DAYS, AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER SAID CHANGE ORDER AND ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, Sealevel Construction has completed the Country Club Boulevard to Edgewood Drive Culvert Project; and additional work was required to offset a waterline; and

WHEREAS, estimated quantities from the original Contract need to be adjusted based on the actual quantities used; and

WHEREAS, the contract price prior to this change order is \$223,725.00; and

WHEREAS, the net increase in contract price to account for the waterline offset and adjustment to quantities is \$7,622.10; and

WHEREAS, the revised contract price would be \$231,387.10; and

WHEREAS, the contract time needs to be increased by five days to account for the additional work; and

WHEREAS, this resolution was sponsored for Administration by Mr. Joseph Fertitta, Councilman, District 4; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council approves Change Order No. 2 for the Country Club Boulevard to Edgewood Drive Culvert project, increasing the contract price by \$7,662.10 and adding five (5) contract days and authorizing the Parish President to sign, execute and administer said change order and any and all relevant documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on November 25, 2014, and does hereby approve Change Order No. 2 for the Country Club Boulevard to Edgewood Drive Culvert project, increasing the contract price by \$7,662.10 and adding five (5) contract days and authorizing the Parish President to sign, execute and administer any and all relevant documents.

BE IT FURTHER RESOLVED, that a certified copy of this resolution shall be forwarded to T.
