RESOLUTION NO. 14-330

RESOLUTION APPROVING THE LOW QUOTE OF LOW LAND CONSTRUCTION CO., INC. IN THE AMOUNT OF \$17,000.00 FOR THE CLEARING AND CLEANING OF THE DITCH NEAR DIPLOMAT WAY AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER AN AGREEMENT AND ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, there is a significantly overgrown, large ditch on the east-side of Diplomat Way; and

WHEREAS, the ditch starts at Talbot Road and extends south for approximately 2,000 feet; and

WHEREAS, three (3) quotes were requested and received as follows:

1.	Low Land Construction Co., Inc	\$17,000.00
2.	Sealevel Construction, Inc.	\$26,900.00
3.	LA Contracting Enterprises, LLC	\$43,000.00

WHEREAS, funding will come from RSTD-A, Project Code # 13020; and

WHEREAS, this Resolution was sponsored for Administration by Mr. Jerry Jones, Councilman, District 1; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council approve the low quote from Low Land Construction Co., Inc. in the amount of \$17,000.00 for the clearing and cleaning of a ditch near Diplomat Way and authorizes the Parish President to sign, execute, and administer an agreement and any and all relevant documents.

THEREFORE BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on November 25, 2014, and does hereby approve the low quote from Low Land Construction Co., Inc. in the amount of \$17,000.00 for the clearing and cleaning of a ditch near Diplomat Way and authorizes the Parish President to sign, execute, and administer an agreement and any and all relevant documents.
