RESOLUTION REAPPOINTING ONE (1) COMMISSIONER TO THE VETERANS' MEMORIAL DISTRICT OF WARD 10 OF LAFOURCHE PARISH BOARD.

WHEREAS, Mr. Irwin Bouvier serves on the Veterans' Memorial District of Ward 10 Board; and

WHEREAS, according to the Lafourche Parish Government's records, Mr. Bouvier's term expired on August 22, 2014; and

WHEREAS, in an email from State Senator Norbert N. "Norby" Chabert, he recommends Mr. Irwin Bouvier be reappointed to the Veterans' Memorial District of Ward 10 Board; and

WHEREAS, this resolution was sponsored for administration by Mr. Daniel Lorraine, District 9; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council take action on this recommendation.
