RESOLUTION ACCEPTING THE LOW BID OF KENWORTH OF SOUTH LOUISIANA, LLC IN THE AMOUNT OF \$140,110.00 FOR THE PURCHASE OF TWO NEW DUMP TRUCKS AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, a bid document was issued for public bids for two new dump trucks; and

WHEREAS, four (4) bids were received as follows; and

Kenworth of South Louisiana DBA Hino of Baton Rouge:	\$142,640.00
ITA Truck Sales and Service, LLC:	\$145,963.38
Empire Truck Sales, LLC:	\$159,852.00

WHEREAS, the funding will come from RSTD-A; and

WHEREAS, this resolution was sponsored for Administration by Mr. Phillip Gouaux, Councilman, District 6; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council accepts the low bid of Kenworth of South Louisiana, LLC in the amount of \$140,110.00 for the purchase of two new dump trucks and authorizes the Parish President to sign, execute and administer any and all relevant documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on December 9, 2014, and does hereby accept the low bid of Kenworth of South Louisiana, LLC in the amount of \$140,110.00 for the purchase of two new dump trucks and authorizes the Parish President to sign, execute and administer any and all relevant documents.
