**RESOLUTION NO. 14-355**

**RESOLUTION APPROVING THE BIDS FOR MISCELLANEOUS MATERIALS FOR THE TIME PERIOD OF JANUARY 2015 THROUGH JUNE 2015 AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER ANY AND ALL RELEVANT DOCUMENTS.**

**WHEREAS**, the Parish requests bids for miscellaneous materials on a semi-annual basis; and

**WHEREAS**, the Parish opened bids for miscellaneous materials for the time period of January 2015 through June 2015; and

**WHEREAS**, a summary of these bids is shown in Exhibit 1, which is attached; and

**WHEREAS**, the materials shown in Exhibit 1 will be used on an as-needed basis; and

**WHEREAS**, the Parish will use the vendors with the lowest prices for the materials whenever the materials are readily available; and

**WHEREAS**, Parish will use the next lowest price whenever materials are not readily available; and

**WHEREAS**, as materials are needed and purchased, the funding will come from the appropriate category in the Parish's Adopted Budget; and

**WHEREAS**, this resolution was sponsored for Administration by Mr. Phillip Gouaux, Councilman, District 7; and

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council approves the bids for miscellaneous materials for the time period of January 2015 through June 2015 and authorizes the Parish President to sign, execute and administer any and all relevant documents.

**THEREFORE, BE IT RESOLVED**, that the Lafourche Parish Council convened in regular session on December 9, 2014, and does hereby approve the bids for miscellaneous materials for the time period of January 2015 through June 2015 and authorizes the Parish President to sign, execute and administer any and all relevant documents.

**BE IT FURTHER RESOLVED**, that a certified copy of this resolution shall be forwarded to Lafourche Parish Government Department of Public Works, Department of Finance, and the Office of the Parish Administrator.
