RESOLUTION APPOINTING ONE (1) COMMISSIONER TO THE BAYOU BLUE FIRE PROTECTION DISTRICT OF TERREBONNE AND LAFOURCHE PARISH BOARD.

WHEREAS, the Bayou Blue Fire Protection District of Terrebonne and Lafourche Parish Board currently has one (1) vacancy which occurred from an expired term; and

WHEREAS, Mr. Carroll McKey's term expired on June 25, 2014; and

WHEREAS, this position was advertised and one (1) application was received; and

WHEREAS, Mr. Nathan Pitre submitted his application to fill one (1) position; and

WHEREAS, this resolution was sponsored for administration by Mr. John Arnold, District 5; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council take action on this application.
