**RESOLUTION NO. 14-313**

**RESOLUTION APPOINTING ONE (1) COMMISSIONER TO REPRESENT THE LAFOURCHE PARISH CORONER'S OFFICE ON THE LAFOURCHE PARISH CHILDREN AND YOUTH PLANNING BOARD.**

**WHEREAS**, Ms. Jamie Folse serves on the Lafourche Parish Children and Youth Planning Board and represented the Lafourche Parish Coroner's Office on the Board; and

**WHEREAS**, according to the Lafourche Parish Government's records, Ms. Jamie Folse's term expired on April 11, 2013; and

**WHEREAS**, in a letter from Lafourche Parish Coroner's office, Dr. John C. King, recommends Ms. Angie Matherne be appointed to the Lafourche Parish Children and Youth Planning Board; and

**WHEREAS**, this resolution was sponsored for administration by Mr. Michael Delatte, District 2; and

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council take action on this recommendation.
