**RESOLUTION NO. 14-309**

**RESOLUTION REAPPOINTING ONE (1) COMMISSIONER TO REPRESENT LAFOURCHE PARISH JUVENILE JUSTICE FACILITY ON THE LAFOURCHE PARISH YOUTH AND PLANNING BOARD.**

**WHEREAS**, James Licalzi serves on the Lafourche Parish Children and Youth Planning Board and represents the Lafourche Parish Juvenile Justice Facility on the Board; and

**WHEREAS**, according to the Lafourche Parish Government’s records, Mr. James Licalzi’s term expired on September 12, 2013; and

**WHEREAS**, a letter from the Lafourche Parish Juvenile Justice Facility recommends Mr. James Licalzi be reappointed to the Lafourche Parish Children and Youth Planning Board; and

**WHEREAS**, this resolution was sponsored for administration by Mr. Aaron Caillouet, District 3; and

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council take action on this recommendation.

**THEREFORE, BE IT RESOLVED**, that the Lafourche Parish Council convened in regular session on October 28, 2014, and does hereby reappoint Mr. James Licalzi to the Lafourche Parish Children and Youth Planning Board to serve a two (2) year term beginning October 28, 2014, and ending October 27, 2016.
