RESOLUTION NO. 14-310

RESOLUTION REAPPOINTING ONE (1) COMMISSIONER TO REPRESENT THE SEVENTEENTH JUDICIAL DISTRICT COURT ON THE LAFOURCHE PARISH CHILDREN AND YOUTH PLANNING BOARD.

WHEREAS, Judge Walter Lanier, III, serves on the Lafourche Parish Children and Youth Planning Board and represents the Seventeenth Judicial District Court on the Board; and

WHEREAS, according to the Lafourche Parish Government's records, Judge Walter Lanier, III's term expired on January 9, 2014; and

WHEREAS, a letter from the Seventeenth Judicial District Court, recommends Judge Walter Lanier, III be reappointed to the Lafourche Parish Children and Youth Planning Board; and

WHEREAS, this resolution was sponsored for administration by Mr. Joe Fertitta, District 4; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council take action on this recommendation.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on October 28, 2014, and does hereby reappoint Judge Walter Lanier, III to the Lafourche Parish Children and Youth Planning Board to serve a two (2) year term beginning October 28, 2014, and ending October 27, 2016.
