**RESOLUTION NO. 14-324**

**RESOLUTION REAPPOINTING ONE (1) COMMISSIONER TO REPRESENT THE OFFICE OF JUVENILE JUSTICE ON THE LAFOURCHE PARISH CHILDREN AND YOUTH PLANNING BOARD.**

**WHEREAS**, Ms. Angela Koenig serves on the Lafourche Parish Children and Youth Planning Board as representative for the Office of Juvenile Justice; and

**WHEREAS**, according to the Lafourche Parish Government's records, Ms. Koenig's term expired on May 21, 2014; and

**WHEREAS**, a letter from the Office of Juvenile Justice recommends Ms. Angela Koenig be appointed to the Lafourche Parish Children and Youth Planning Board; and

**WHEREAS**, this resolution was sponsored for administration by Mr. Jerry Jones, District 1; and

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council take action on this recommendation.

**THEREFORE, BE IT RESOLVED**, that the Lafourche Parish Council convened in regular session on November 11, 2014, and does hereby reappoint Ms. Angela Koenig to the Lafourche Parish Children and Youth Planning Board to serve a two (2) year term beginning November 11, 2014, and ending November 10, 2016.
