

The following ordinance was submitted for introduction by Mr. Joe Fertitta in regular session convened on October 28, 2014:

PROPOSED ORDINANCE

The following Ordinance, having been previously introduced and published, was offered for final adoption by Mr. Joe Fertitta, seconded by Mr. Phillip Gouaux:

ORDINANCE NO. 5554

AN ORDINANCE AMENDING AND RE-ENACTING ORDINANCE NO. 1335 AND AMENDING AND RE-ENACTING CHAPTER 26 - OFFENSES AND MISCELLANEOUS PROVISIONS, ARTICLE I - IN GENERAL, SECTION 26-5 - CURFEW ON DOOR-TO-DOOR PEDDLING OR HAWKING OF THE LAFOURCHE PARISH CODE OF ORDINANCES AS IT PERTAINS TO AMENDING THE CURFEW TIME (~~8:00 P.M.~~ TO SUNSET); AND AMENDING AND RE-ENACTING ARTICLE I, SECTION 26-5 THUS REFLECTING THE NEW CODE OF ORDINANCES.

BE IT ORDAINED, by the Lafourche Parish Council, convened in Regular Session on November 11, 2014, that:

SECTION 1.

WHEREAS, this ordinance shall amend Ordinance No. 1355 and amend and re-enact Chapter 26 - Offenses and Miscellaneous Provisions, Article I - In General, Section 26-5 - Curfew on Door-to-Door Peddling or Hawking of the Lafourche Parish Code of Ordinances as it pertains to amending the curfew time (~~8:00 p.m.~~ to sunset); and amending and re-enacting Article I, Section 26-5 thus reflecting the new Code of Ordinances.

Amending and re-enacting the following of Ordinance 1355:

SECTION 15:8 CURFEW ON DOOR TO DOOR PEDDLING OR HAWKING

No person shall, without permission, peddle or hawk merchandise or attempt to make sales or solicit orders on a door-to-door basis on private premises between ~~8:00 p.m.~~ sunset and 8:00 a.m. in the parish.

Amending and re-enacting the following thus reflecting the new Code of Ordinances:

~~SECTION 15:8 CURFEW ON DOOR TO DOOR PEDDLING OR HAWKING~~

Sec. 26-5. Curfew on door-to-door peddling or hawking

No person shall, without permission, peddle or hawk merchandise or attempt to make sales or solicit orders on a door-to-door basis on private premises between ~~8:00 p.m.~~ sunset and 8:00 a.m. in the parish.

SECTION 2. The Sheriff of this Parish is hereby specifically requested to assist in the enforcement of the provisions of this Ordinance.

SECTION 3. If any section, clause, paragraph, provision or portion of these Regulations shall be held invalid by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of these regulations.

SECTION 4. Any person who violates the provisions of this Ordinance shall upon conviction thereof, be punished by imprisonment in the parish jail for a period of not more than thirty (30) days, or by fine of not more than five hundred dollars (\$500.00) or by both such imprisonment and fine, at the discretion of the Court.

SECTION 5. All Ordinances or parts of Ordinances by the Lafourche Parish Council conflicting with or inconsistent with the provisions of these regulations are hereby repealed.

SECTION 6. This ordinance shall be published in the Official Journal of the Lafourche Parish Council in the manner provided by law.

SECTION 7. This Ordinance, having been submitted in writing, having been read and adopted by sections at a public meeting of said Council, was then submitted to an official vote as a whole, the vote thereon being as follows:
