**PROPOSED ORDINANCE**

The following Ordinance, having been previously introduced and published, was offered for final adoption by Mr. Phillip Gouaux, seconded by Mr. Lindel Toups:

**ORDINANCE NO. 5555**

**AN ORDINANCE RESCINDING ORDINANCE NO. 3641 AS IT PERTAINS TO DESIGNATING A SECTION OF HYLAND DRIVE AS A “ONE-WAY” STREET, WARD (4), DISTRICT (7) OF THE PARISH OF LAFOURCHE, STATE OF LOUISIANA.**

**BE IT ORDAINED**, by the Lafourche Parish Council, convened in Regular Session on November 11, 2014, that:

**SECTION 1.** This Ordinance does hereby rescind Ordinance No. 3641 as it pertains to designating a section of Hyland Drive as a “one-way” street, Ward (4), District (7) of the Parish of Lafourche, State of Louisiana.

**SECTION 2.** All Ordinances or parts of Ordinances by the Lafourche Parish Council conflicting with or inconsistent with the provisions of these regulations are hereby repealed.

**SECTION 3.** If any section, clause, paragraph, provision or portion of these regulations shall be held invalid by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of these regulations.

**SECTION 4.** This ordinance shall be published in the Official Journal of the Lafourche Parish Council in the manner provided by law.

**SECTION 5.** This Ordinance, having been submitted in writing, having been read and adopted by sections at a public meeting of said Council, was then submitted to an official vote as a whole, the vote thereon being as follows:
