

The following ordinance was submitted for introduction by Mr. Joe Fertitta, in regular session convened on October 28, 2014.

### **PROPOSED ORDINANCE**

The following Ordinance, having been previously introduced and published, was offered for final adoption by Mr. Joe Fertitta, seconded by Mr. John Arnold:

#### **ORDINANCE NO. 5561**

**AN ORDINANCE AUTHORIZING THE PARISH PRESIDENT TO ENTER INTO AN AGREEMENT WITH PROGRESSIVE WASTE SOLUTIONS, OF LA, INC., AND ENTER INTO INTERGOVERNMENTAL AGREEMENTS WITH THE TOWNS OF LOCKPORT AND GOLDEN MEADOW RELATIVE TO THE PROGRESSIVE WASTE SOLUTIONS, OF LA, INC. AGREEMENT AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER SAID AGREEMENTS AND ANY AND ALL RELEVANT DOCUMENTS.**

**WHEREAS**, Lafourche Parish Government needs parish-wide garbage and trash collection; and

**WHEREAS**, said agreement shall commence on January 1, 2015 and terminate on December 31, 2019; and

**WHEREAS**, it shall not be an exclusive contract as per the Public Bid Law; and

**WHEREAS**, this ordinance was sponsored for Administration by Mr. Joseph Fertitta, Councilman, District 4; and

**WHEREAS**, it is recommended by the Administration that the Lafourche Parish Council approve the agreement with Progressive Waste Solutions, of LA, Inc., and the Intergovernmental Agreements with the Towns of Lockport and Golden Meadow relative to Progressive Waste Solutions, of LA, Inc. agreement and authorizing the Parish President to sign, execute and administer said Agreements and any and all relevant documents.

**BE IT ORDAINED**, by the Lafourche Parish Council, convened in regular session on November 11, 2014, that:

**SECTION 1.** The Parish President is hereby authorized to enter into a agreement with Progressive Waste Solutions, of LA, Inc., the term to begin on January 1, 2015 and terminate on December 31, 2019, and is authorized to enter into Intergovernmental Agreements with the Towns of Lockport and Golden Meadow relative to said contract, and is hereby authorized to sign said agreement with Progressive Waste Solutions, of LA, Inc. and said Intergovernmental Agreements with Towns of Lockport and Golden Meadow.

**SECTION 2.** If any section, clause, paragraph, provision, or portion of these Regulations shall be held invalid by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of these regulations.

**SECTION 3.** All Ordinances or parts of Ordinances by the Lafourche Parish Council conflicting with or inconsistent with the provisions of these regulations are hereby repealed.

**SECTION 4.** This ordinance shall be published in the Official Journal of the Lafourche Parish Council in the manner provided by law.

**SECTION 5.** A certified copy of this Ordinance shall be forwarded to Progressive Waste Solutions, of LA, Inc., Lafourche Parish Government Department of Solid Waste, Department of Finance, and the Office of the Parish Administrator.

**SECTION 6.** This Ordinance, having been submitted in writing, having been read and adopted by sections at a public meeting of said Council, was then submitted to an official vote as a whole, the vote thereon being as follows:
