The following ordinance, having been previously introduced and published, was offered for final adoption by Mr. Phillip Gouaux, seconded by Mr. Jerry LaFont.

**ORDINANCE NO. 5567**

**ORDINANCE RESCINDING ORDINANCE NO. 4457 AS IT PERTAINS TO SUPPORTING LAFOURCHE PARISH SALES AND USE TAX ORDINANCE AND AMENDING THEIR PROCEDURES USED TO COLLECT SALES AND USE TAX FOR ALL TAXING AUTHORITIES LOCATED IN LAFOURCHE PARISH.**

**WHEREAS**, The Lafourche Parish School Board Sales and Use Tax Office is amending their current Sales and Use Tax Ordinance and as a result a new ordinance will be submitted for approval; and

**WHEREAS**, this ordinance was sponsored for Administration by Mr. Phillip Gouaux, Councilman, District 7; and

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council hereby approve rescinding Ordinance No. 4457, in its entirety, as it pertains to supporting Lafourche Parish Sales and Use Tax Ordinance and amending their procedures used to collect sales and use tax for all taxing authorities located in Lafourche Parish.

**THEREFORE BE IT ORDAINED**, that the Lafourche Parish Council convened in Regular Session on November 25, 2014, and does hereby approve rescinding Ordinance No. 4457, in its entirety, as it pertains to supporting Lafourche Parish Sales and Use Tax Ordinance and amending their procedures used to collect sales and use tax for all taxing authorities located in Lafourche Parish.

**BE IT FURTHER ORDAINED**, that a certified copy of this Ordinance shall be forwarded to Lafourche Parish Government Department of Finance, and the Office of the Parish Administrator.

**BE IT FURTHER ORDAINED**, that;

**SECTION 1.** If any provision or item of this ordinance or the application thereof is held invalid, such invalidity shall not effect other provisions, items or application of this ordinance which can be given affect without the invalid provisions, items or application, and to this end the provisions of this ordinance are declared severable.

**SECTION 2.** All Ordinances by the Lafourche Parish Council conflicting with or inconsistent with the provisions of these regulations are hereby repealed.

**SECTION 3.** This Ordinance shall be published in the Official Journal of the Lafourche Parish Council in the manner provided by law.

**SECTION 4.** This Ordinance, having been submitted in writing, having been read and adopted by sections at a public meeting of said Council, was then submitted to an official vote as a whole, the vote thereon being as follows:
