

The following ordinance was introduced by Mr. Joe Fertitta in regular session convened on November 11, 2014.

PROPOSED ORDINANCE

The following ordinance, having been previously introduced and published, was offered for final adoption by Mr. Phillip Gouaux, seconded by Mr. Jerry Lafont.

ORDINANCE NO. 5569

ORDINANCE PROVIDING FOR A 2014 SUPPLEMENTAL APPROPRIATION (14-033) WITHIN THE 2014 OPERATIONS AND MAINTENANCE AND CAPITAL BUDGET TO COVER THE REPAIRS OF THE GALLIANO BRIDGE AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER SAID TRANSACTIONS AS PROVIDED FOR BY ARTICLE VI OF THE LAFOURCHE PARISH HOME RULE CHARTER.

WHEREAS, Three Hundred Fifty Thousand dollars (\$350,000) is necessary to transfer from Road Sales Tax District 2 to cover the needed repairs to the Galliano Bridge; and

WHEREAS, the money will be used for engineering fees, topographic survey, geotechnical investigation and construction cost; and

WHEREAS, this ordinance was sponsored for Administration by Mr. Daniel Lorraine, Councilman, District 9; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the council approve a 2014 Supplemental Appropriation (14-033) within the 2014 Operations and Maintenance and Capital Budget to cover the repairs to the Galliano Bridge and authorizes the Parish President to sign, execute, and administer said transactions as provided for by Article VI of the Lafourche Parish Home Rule Charter.

THEREFORE BE IT ORDAINED, by the Lafourche Parish Council, convened in Regular Session on November 25, 2014, and hereby approves a 2014 Supplemental Appropriation (14-033) within the 2014 Operations and Maintenance and Capital Budget to cover the repairs to the Galliano Bridge and authorizes the Parish President to sign, execute, and administer said transactions as provided for by Article VI of the Lafourche Parish Home Rule Charter; and

BE IF FURTHER ORDAINED, that:

SECTION 1. A Supplemental Appropriation of the 2014 Operations and Maintenance Budget is hereby approved as follows:

FUND 161 ROAD SALES TAX DISTRICT 2

To cover the repairs to the Galliano Bridge:

1. An increase in MISCELLANEOUS in the amount of \$350,000

SECTION 2. A Supplemental Appropriation of the 2014 Capital Budget is hereby approved as follows:

FUND 299 CAPITAL PROJECT FUND

To cover the repairs to the Galliano Bridge:

1. An increase in OTHER REVENUES in the amount of \$350,000
2. An increase in CAPITAL OUTLAY in the amount of \$350,000

SECTION 3. If any provision or item of this ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items or application of this ordinance which can be given effect without the invalid provisions, items or application, and to this end the provisions of this ordinance are declared severable.

SECTION 4. All Ordinances by the Lafourche Parish Council conflicting with or inconsistent with the provisions of these regulations are hereby repealed.

SECTION 5. This Ordinance shall be published in the Official Journal of the Lafourche Parish Council in the manner provided by law.

SECTION 6. A certified copy of this ordinance shall be forwarded to Lafourche Parish Government's Department of Finance, Department of Public Works and the Office of the Parish Administrator.

SECTION 7. This Ordinance, having been submitted in writing, having been read and adopted by sections at a public meeting of said council, was then submitted to an official vote as a whole, the vote thereon being as follows:
