RESOLUTION NO. 16-367

A RESOLUTION REAPPOINTING ONE (1) COMMISSIONER TO REPRESENT THE OFFICE OF JUVENILE JUSTICE ON THE LAFOURCHE PARISH CHILDREN AND YOUTH PLANNING BOARD.

WHEREAS, Angela Koenig serves on the Lafourche Parish Children and Youth Planning Board representing the Office of Juvenile Justice; and

WHEREAS, according to the Lafourche Parish Government’s records, Ms. Koenig’s term will expire on November 10, 2016; and

WHEREAS, in a letter from the Office of Juvenile Justice, Angela Koenig, would like to be reappointed to the Lafourche Parish Children and Youth Planning Board; and

WHEREAS, this resolution was sponsored for Administration by Mr. Aaron Melvin, Councilman, District 4; and

WHEREAS, it is recommended by the Administration of Lafourche Parish Government that the Council take action on this recommendation.
