PROPOSED ORDINANCE

The following ordinance, having been previously introduced and published, was offered for final adoption by Mr. Michael Matherne, seconded by Mr. Phillip Gouaux.

**ORDINANCE NO. 4044**

**ORDINANCE AMENDING AND RE-ENACTING SECTION 2:200 (A) OF SUB-CHAPTER "C" OF CHAPTER 2 OF THE CODE OF THE ORDINANCES FOR THE LAFOURCHE PARISH COUNCIL BY CHANGING THE TIME OF THE REGULAR MEETINGS FROM 6:00 PM TO 5:00 PM.**

**BE IT ORDAINED,** by the Lafourche Parish Council, convened in Regular Session on April 24, 2007, that:

**SECTION 1.** Section 2:200 (A) of Sub-Chapter "C" of Chapter 2 of the Lafourche Parish Code of Ordinances is hereby amended and re-enacted to read as follows:

CHAPTER 2 ADMINISTRATION AND ORGANIZATION

SUB-CHAPTER "C"

PROVISIONS GOVERNING OPERATIONS OF PARISH GOVERNING BODY

PART I IN GENERAL

SECTION 2:200. MEETINGS OF THE PARISH COUNCIL

A. Regular meetings of the Lafourche Parish Council will be held on the second and fourth Tuesday of the month at ~~6:00 p.m.~~ **5:00 p.m.** in the Council meeting room at the Barrios Center, Raceland, Louisiana. By a favorable vote of at least five (5) members, regular or special meetings may be held at other locations within the Parish of Lafourche. Meetings will be publicly advertised as required by law.

**SECTION 2.** If any provision or item of this Ordinance or the application thereof is held invalid, such invalidity shall not effect other provisions, items of this Ordinance which can be given affect without the invalid provisions, items or application, and to this end the provisions of this ordinance are declared severable.

**SECTION 3.** All Ordinance or parts of Ordinances by the Lafourche Parish Council conflicting with or inconsistent with the provisions of these regulations are hereby repealed.

**SECTION 4.** This Ordinance shall be published in the Official Journal of the Lafourche Parish Council in the manner provided by law.

**SECTION 5.** This Ordinance, having been submitted in writing, having been read and adopted by sections at a public meeting of said Council, was then submitted to an official vote as a whole, the vote thereon being as follows:
